**Drought and Water Shortage Management Plans (4 SWRCB Contact Hours) Wednesday, March 22, 2023 @ 8:30 am -12:30 pm**

This course will cover the different types of forms of water conservation planning with information based on your water system needs and capabilities. It will also review the tools and public education materials available to systems implementing a conservation plan. Lastly, this class will also cover potential financial issues with revenue that can occur when not considered in the planning and implementation of a water shortage/conservation plan.

New requirements in SB 552 for small water systems and counties for water shortage contingency planning, and Financial and technical assistance programs **Drought Background** Overview of California hydro-climatology, including the hydrology of the state's most significant historical droughts, understanding drought risk and climate change, Review of lessons learned in past droughts, as well as expected drought impacts & basic concepts of drought vulnerability & drought resilience.

**Tanks and Maintenance (4 SWRCB Contact Hours) – Wednesday, May 3, 2023 @ 8:30 am -12:30 pm**

Steel tanks have been proven to provide a long life. With many tanks in the country over 100 years old, these tanks have proven an excellent value to their Owners. One issue facing the industry has been corrosion appearing above the water line in the vapor space. This presentation will show examples of issues that other owners have faced and the solutions that has solved the problems. Additional topics in the presentation will include coating and retrofit options to bring their tanks up to current code including seismic. In closing, The Student shall understand various options available to them to lower corrosion opportunities and make their coatings last much longer. Additional topics will include concrete water tanks and retrofitting options as well as a basic overview of concrete.

**Emergency Response Plan (3 SWRCB Contact Hours) – Wednesday, June 14, 2022 @ 8:30 am -12:30 pm**

This course will cover the procedures and documents required by the state and funding agencies utilized in Emergency response. You will also receive instruction on how to educate the public about emergency response as it relates to the water system. **Public safety power shutoff (PSPS)** is the effort to temporarily cut power to electric lines that may fail in certain weather conditions in specific areas to reduce electric facility-caused fire risk.
