 Regulatory Updates with an emphasis on the Lead and Copper Rule (4 SWRCB Contact Hours) Wednesday, October 18, 2023 @ 8:30 am -12:30 pm

This course will review the background of Regulatory Setting. Covers updates and existing regulations and how they apply to you water system.

The training is an insight into what the SWRCB will be working on in 2023 and we'll get to see what regulations or changes may be passed this year. By the end of the session, you'll learn the list of regulatory priorities set forth by the California State Water Resources Control Board for Calendar year 2023 and you'll understand the major regulatory changes proposed by the SWRCB. It's worth showing you the change in priorities from last year. I'll talk about the HOW AND WHY approach.

Drinking Water System Security Training (4 SWRCB Contact Hours) – Wednesday, December 6, 2023 @ 8:30 am -12:30 pm

This course highlights the vulnerability of our drinking water distribution systems to accidental or intentional contamination, and the role that the distribution system plays in that vulnerability. The course will cover potential threats, monitoring for those threats and the role management, operators, and the local community need to take in the security of the distribution system. Other areas include the vulnerability assessments and the chemical security act as it relates to water.

Water systems are critical to every community. Protection of public drinking water systems must be a high priority for local officials and water system owners and operators to ensure an uninterrupted water supply, which is essential for the protection of public health (safe drinking water and sanitation) and safety (firefighting). Adequate security measures will help prevent loss of service through terrorist acts, vandalism, or pranks. If your system is prepared, such actions may even be prevented. The appropriate level of security is best determined by the water system at the local level, potential threats and cyber security.
