1 PLEASE TAKE NOTICE THAT on December 7, 2023, in Department 1 of the above-  
2 entitled Court located at 4050 Main Street, Riverside, California, at 8:30 a.m. or as soon  
3 thereafter as the matter may be heard, plaintiff will move, and hereby moves, for an Order of  
4 Court that Shadow Mountain Ranch LLC (hereafter, "Shadow Mountain") may be named and  
5 served as an additional defendant in consolidated Action Number CIVSB 2218461 filed in the  
6 San Bernardino Superior Court. This motion is based upon the following grounds:

7 1. In the Judgment entered in the consolidated action in *City of Barstow, et al. v. City of*  
8 *Adelanto, et al.*, Riverside Superior Court Action No. CIV 208568 (hereafter, “*City of*  
9 *Barstow*”), the Court suggested that Plaintiff file this Action in the San Bernardino Superior  
10 Court, naming as defendants herein persons who are not already parties to *City of Barstow*, and  
11 who are determined to be producing annually more than 10 acre feet of groundwater in the  
12 adjudicated Mojave Basin Area (see Court’s Minute Order dated July 21, 2022, in *City of*  
13 *Barstow*).

14 2. Shadow Mountain owns real property located within the adjudicated boundaries of the  
15 Mojave Basin Area, i.e., APN 0489-161-11, and produces from such property an estimated  
16 1,700 acre feet of groundwater annually.

17 3. The prior owner of the referenced real property, i.e., Ace Exploration and Water Drilling  
18 Company, was previously named as a defendant in *City of Barstow*. After filing for bankruptcy  
19 protection, however, Ace Exploration and Water Drilling Company was dismissed from *City of*  
20 *Barstow*, without prejudice. Thus, there exists no legal impediment to naming Shadow Mountain  
21 as a defendant in this Action.

## **MEMORANDUM OF POINTS AND AUTHORITIES**

Plaintiff submits this Memorandum in support of the foregoing motion.

## A. The Judgment in *City of Barstow*

In the Judgment entered in *City of Barstow*, in pertinent part, the Court ordered as follows:

I. INTRODUCTION . . . B. The MWA Cross-Complaint. . . . the MWA cross-complaint, as currently amended, requests a declaration that the available native water supply to the Mojave Basin Area (not including water imported from the California State Water project) is inadequate to meet the demands of the combined Parties and requests a determination of the water rights of whatever nature within the MWA boundaries and the Mojave Basin Area. The MWA has named as Parties several hundred Producers with the Basin Area.

## II. DECREE . . . A. JURISDICTION, PARTIES, DEFINITIONS.

#### 4. Definitions. . . .

1. Groundwater – Water beneath the surface of the ground and within the zone of saturation; i.e., below the existing water table, whether or not flowing through known and definite channels.

s. Mojave Basin Area or Basin Area – The area shown on Exhibit “A” that lies within the boundaries of the line labeled “Limits of Adjudicated Area” which generally includes the area tributary to the Mojave River and its tributaries except for such area not included within the Mojave Water Agency’s jurisdiction.<sup>1</sup>

Thus, the *City of Barstow* Judgment governs the extraction or production of “Water beneath the surface of the ground and within the zone of saturation,” in the Mojave Basin Area adjudicated area, which is a specifically defined geographic area (see Exhibit 1 hereto, which includes drawings of the Mojave Basin Area adjudicated boundaries). The Judgment further provides that any person producing more than 10 acre feet of groundwater annually must be made subject to the adjudication, as follows:

Any Minimal Producer whose annual Production exceeds ten (10) acre-feet in any Year following the date of entry of Judgment shall be made a party pursuant to Paragraph 12 and shall be subject to Administrative, Replacement Water, Makeup Water and Biological Resources Assessment.

<sup>1</sup> Plaintiff requests the Court judicially notice the aforesaid provisions of the Judgment entered on January 10, 1996, in *City of Barstow*, pursuant to Evidence Code section 452(d), which authorizes the Court to judicially notice "Records of (1) any court of this state . . .".

1 (Judgment, page 5, lines 1-5; emphasis added.)

2 Accordingly, any person producing more than 10 acre feet of groundwater annually from  
3 overlying properties in the Mojave Basin Area must be made subject to the provisions of the  
4 *City of Barstow* Judgment. To accomplish that end, and pursuant to the Court's suggestion in  
5 *City of Barstow* (see Court's Minute Order dated July 21, 2022 in *City of Barstow*), this Action  
6 was filed in the San Bernardino Superior Court.

7 **B. Real Property Owned by Shadow Mountain**

8 Shadow Mountain is a limited liability company formed in Colorado, and registered in  
9 California. The real property owned and operated by Shadow Mountain (APN 0489-161-11) is  
10 located within the adjudicated boundaries of the Mojave Basin Area. From water wells located  
11 on its identified property, Shadow Mountain produces an estimated 1,700 acre feet of  
12 groundwater annually (see attached Ruesch supporting declaration, and Exhibit 2 hereto.) The  
13 aerial photography at the top of the first page of Exhibit 2 demonstrates that Shadow Mountain's  
14 property is located within the Mojave Basin Area adjudicated boundary. The remainder of the  
15 first page of Exhibit 2 depicts Shadow Mountain's agricultural operations which are dependent  
16 upon "Water beneath the surface of the ground and within the zone of saturation" -- all of which  
17 is produced by water wells located on APN 0489-161-11. The additional pages attached to  
18 Exhibit 2 are photographs depicting Shadow Mountain's agricultural operations on its  
19 referenced real property within the Mojave Basin Area.

20 Accordingly, Shadow Mountain should be made a defendant in this Action and, thereby,  
21 subject to the provisions of the Judgment entered in *City of Barstow*, because (a) Shadow  
22 Mountain's property is located within the adjudicated boundaries of the Mojave Basin Area, and  
23 (b) more than 10 acre feet of "Water beneath the surface of the ground and within the zone of  
24 saturation" is produced annually from water wells located on Shadow Mountain's property.

25 **C. Shadow Mountain's predecessor-in-interest**

26 A previous owner of the referenced real property, Ace Exploration and Water Drilling  
27 Company, was previously named as a defendant in the *City of Barstow* litigation. After it filed

1 for bankruptcy protection, however, Ace Exploration and Water Drilling Company was  
2 dismissed from *City of Barstow*, without prejudice. (See Exhibit 3 hereto.) Thus, there is no  
3 legal impediment to naming Shadow Mountain as a defendant in this action.

4 **D. Whether groundwater pumped by Shadow Mountain emanates from a source other  
than the Mojave River and its tributaries is irrelevant.**

5       Shadow Mountain claims it should not be made subject to the provisions of the *City of*  
6 *Barstow* Judgment because the groundwater it produces on the referenced real property allegedly  
7 emanates from a source other than the Mojave River or its tributaries. Shadow Mountain is  
8 mistaken.<sup>2</sup>

9       1. **The Judgment applies to all groundwater produced from water wells located  
within the Mojave Basin Area adjudicated boundaries.**

10      Whether some or all of the groundwater pumped by Shadow Mountain emanates from  
11 an underground source other than the Mojave River and its tributaries is irrelevant. This is so  
12 because nothing in the *City of Barstow* Judgment limits its application to groundwater derived  
13 only from the Mojave River or its tributaries. The Judgment's reference to "the area tributary  
14 to the Mojave River and its tributaries" merely describes "generally," the boundaries of the  
15 adjudicated Mojave Basin Area, to wit:

16       s. Mojave Basin Area or Basin Area – The area shown on Exhibit "A" that lies within  
17 the boundaries of the line labeled "Limits of Adjudicated Area which generally includes  
18 the area tributary to the Mojave River and its tributaries except for such area not  
19 included within the Mojave Water Agency's jurisdiction.

20 (Emphasis added.)

21      Therefore, the Judgment's reach extends to all "Water beneath the surface of the ground  
22 and within the zone of saturation" underlying all real property located within the adjudicated  
23 boundaries of the Mojave Basin Area – including Shadow Mountain's property. Nothing in the  
24 Judgment excludes groundwater produced from water wells located within the boundaries of the  
25 Mojave Basin Area that allegedly is derived from a source or sources other than the Mojave

27       <sup>2</sup> Plaintiff also disputes Shadow Mountain's claim that the groundwater it produces does not  
28 include groundwater derived from the Mojave River and its tributaries.

## River and its tributaries.

## **2. Shadow Mountain's groundwater is not "supplemental water."**

Shadow Mountain also appears to claim that groundwater pumped from water wells located on its property is “supplemental water” that should not be constrained or regulated by the *City of Barstow* Judgment. Shadow Mountain is again mistaken. In pertinent part, the Judgment defines “supplemental water” to be “Water **imported** to the Basin from outside the Basin Area” (Judgment, p. 13, lines 12-13, emphasis added). Providing further clarification, paragraph 9 of the Judgment states, “**MWA shall develop conveyance or other facilities to deliver this Supplemental Water . . .**” (Judgment, p. 17, line 9 to p. 18, line 1; emphasis added.)

Thus, “Supplemental Water” is water “ imported to the Basin from outside the Basin Area” by the actions of MWA or other persons; or surface flows that are captured before they could be lost to the Basin Area; or water otherwise acquired by Watermaster. The term Supplemental Water does not apply to water that reaches the groundwater underlying the Basin Area by natural forces of nature, whether it be from storm runoff, the natural flow of the Mojave River or its tributaries, or other natural causes. And it does not include “Water [existing] beneath the surface of the ground and within the zone of saturation” underlying properties located within the Mojave Basin Area adjudicated boundaries – including Shadow Mountain’s property. Regardless of the underground source or sources of water pumped from wells on Shadow Mountain’s property, such may not be characterized as “Supplemental Water” as that term is defined and intended in the Judgment.

Therefore, Shadow Mountain's claims that (a) the groundwater pumped from wells located on its property is Supplemental Water, and (b) the Judgment does not apply to groundwater, the source of which is other than the Mojave River or its tributaries, both fail.

Accordingly, all requirements for making Shadow Mountain a defendant in the San Bernardino lawsuit are met, because: (a) Shadow Mountain's property is located within the adjudicated boundaries of the Mojave Basin Area, and (b) more than 10 acre feet annually of

1 "Water beneath the surface of the ground and within the zone of saturation" is produced from  
2 water wells located on Shadow Mountain's property.

3 **E. Conclusion**

4 For the foregoing reasons, the Court should grant plaintiff's motion and Order that,  
5 following service upon it of a copy of plaintiff's complaint, Shadow Mountain shall be deemed  
6 a defendant in this Action.

6. Based upon the area being irrigated and the crops grown (alfalfa), it is estimated that about 1,700 acre feet of groundwater annually.





## APPENDIX A MOJAVE BASIN AREA ADJUDICATION


### INDEX OF MAPS SHOWING

GEOLOGIC AND OTHER PERTINENT FEATURES**





# Mojave Basin Area Adjudicated Subareas








