1 Leland P. McElhaney declares and states:

2 1. I am an attorney at law duly licensed to practice in all courts of the State of California,
3 and a principal in the law firm of Brunick, McElhaney & Kennedy, PLC, counsel of record for
4 Plaintiff, the Mojave Water Agency in this proceeding. I have personal knowledge of all matters
5 set forth herein and, if called as a witness, I could and would testify competently thereto.

6 2. On June 8, 2026, Plaintiff filed and served WATERMASTER'S STATUS
7 CONFERENCE STATEMENT. In pertinent part, Plaintiff reported therein that the First
8 Amended Complaint had been served on defendants, the Prem Reddy Family Trust (Doe 48) and
9 Indalfer Alfaro-Saucedo (Doe 4), and that service attempts have been unsuccessful as to
10 defendants, Tamara Cann (Doe 53) and Henghe LLC.

11 3. On June 12, 2026, the Court issued its Order to Show Cause as to whether sanctions
12 should be imposed "for Failure to timely file proof of service on complaint pursuant to CRC
13 3.110(b & f)." Although the Order does not indicate the names of the defendants as to whom
14 proofs of service were not timely filed, it appears this may relate to the service on defendants,
15 the Prem Reddy Family Trust and Indalfer Alfaro-Saucedo, and perhaps the lack of service as
16 to defendants, Tamara Cann and Henghe LLC.

17 4. California Rule of Court 3.110, subdivision (b) provides that "When the complaint is
18 amended to add a defendant, the added defendant must be served and proof of service must be
19 filed within 30 days after the filing of the amended complaint."

20 5. As indicated in Exhibit 1 hereto, on May 29, 2026, after paying a process server to
21 perform a "skip trace" on The Prem Reddy Family Trust (Doe 48), which identified Cogency
22 Global as the agent for service for The Prem Reddy Family Trust, Plaintiff attempted to serve
23 The Prem Reddy Family Trust (Doe 48) by service on its agent for service, Cogency Global.
24 However, on June 9, 2026, Plaintiff received from Cogency Global a Notice of Returned
25 Document, stating "Cogency Global does not serve or no longer serves as the agent for service
26 of process for the entity identified in the document" (Exhibit 2 hereto). After receiving the
27 Notice of Returned Document, Plaintiff attempted to serve the trustee of the Prem Reddy Trust
28

1 at addresses identified for the Trust. Those efforts a service also were unsuccessful. See Exhibit
2 3 attached hereto which is the process server's Declaration of non-service. Plaintiff then
3 authorized a second skip trace investigation to determine a valid service address for the trustee
4 of the Prem Reddy Family Trust and, upon ascertaining what appears to be a residential address
5 for the trustee (Dr. Prem Reddy), Plaintiff again attempted to effectuate service upon the trustee
6 of the Trust. As of the writing of this declaration, I have not yet received a report as to whether
7 that additional service effort has been successful. If it is not, Plaintiff will seek leave of Court
8 to effectuate service on The Prem Reddy Family Trust by publication.

9 6. As indicated in Exhibit 4 hereto, Indalfer Alfaro-Saucedo (Doe 4) was served on April
10 7, 2026, and *the Proof of Service of Summons was filed on April 14, 2026*. An earlier attempt
11 to serve Indalfer Alfaro-Saucedo was unsuccessful (see Declaration of Non-Service attached
12 as Exhibit 4 hereto). Mr. Alfaro-Saucedo owns two parcels of real property in the Mojave Basin
13 area, i.e., APN 0469-011-78/79 (the "Property"). Mr. Alfaro-Saucedo's Property was previously
14 owned by Al J. Keel and Barbara Keel. On August 28, 1996, Harry Ormsby (an original
15 stipulating party listed in Exhibit B of the Judgment in *City of Barstow et al., v. City of*
16 *Adelanto, et al.*["*City of Barstow*"]) transferred 90 acre-feet of BAP to Al J. Keel and Barbara
17 Keel, who stipulated to the Judgment in *City of Barstow* on July 15, 1996. On January 27, 1999,
18 Mr. & Mrs. Keel transferred 60 acre-feet of BAP to the Victor Valley Water District, and on
19 February 28, 2007, Mr. & Mrs. Keel transferred the remaining 30 acre-feet of BAP to Paul and
20 Sandra Russavage (who stipulated to the Judgment in *City of Barstow* on February 3, 2007). On
21 April 18, 2019, Mr. & Mrs. Russavage sold the property to the current owner, Mr. Alfaro-
22 Saucedo; however, almost ten years earlier, on July 2, 2009, Mr. & Mrs. Russavage sold their
23 entire 30 acre-feet BAP right to the Helendale CSD. Accordingly, when Mr. Alfaro-Saucedo
24 purchased the Property, the seller was unable to convey to Mr. Alfaro-Saucedo a BAP right
25 under the terms of the Judgment. Although Mr. Alfaro-Saucedo has not yet stipulated to the
26 Judgment in *City of Barstow*, nonetheless, as a "successor" to stipulating Parties to the
27 Judgment, Mr. Alfaro-Saucedo is deemed to be: (a) bound by the Judgment; (b) without a
28

1 correlative right to groundwater in the basin (because his predecessors waived and relinquished
2 their correlative water rights when they stipulated to the Judgment); (c) without a BAP right
3 under the Judgment because his predecessor's BAP right was transferred to the Helendale CSD
4 before Mr. Alfaro-Saucedo obtained an ownership interest in the Property; and (d) required to
5 pay a Replacement Assessment for any groundwater Mr. Alfaro-Saucedo pumps or has pumped.
6 Having confirmed the forgoing ownership history, Plaintiff has filed a dismissal of Mr. Alfaro-
7 Saucedo as a defendant in this proceeding (*Mojave Water Agency v. All persons etc.*), without
8 prejudice, and will take appropriate steps in *City of Barstow* as to Mr. Alfaro-Saucedo's
9 Replacement Assessment obligation.

10 7. Plaintiff has not yet been able to ascertain a service address for defendant, Tamara Cann
11 (Doe 53). However, Plaintiff has determined that she was a part owner of properties that no
12 longer produce groundwater for the unlawful cultivation of cannabis and are not producing more
13 than 10 acre-feet of groundwater annually. Accordingly, Plaintiff has filed a dismissal, without
14 prejudice, as to defendant Tamara Cann.

15 8. As to defendant Henghe LLC (APN 0457-012-13 and 14; 0457-061-04, 05, 06, 07, 13,
16 34; 0457-231-34 and 35), on nine (9) separate dates, i.e., November 3, 2022, December 3, 2022,
17 December 8, 2024, December 12, 2024, and April 13, 15, 17, 20 and 22, 2026, Plaintiff
18 attempted to serve copies of the pleadings at the service address for Henghe LLC listed on the
19 Secretary of State's website and at another possible address for this defendant (see declarations
20 of non-service attached as Exhibits 5, 6, and 7 hereto; Secretary of State "Business Search" for
21 Henghe LLC, Exhibit 8 hereto; and additional service address information for Henghe LLC,
22 Exhibit 9 hereto). On July 23, 2026, Plaintiff mailed to Henghe LLC at the service address for
23 said defendant listed on the Secretary of State's website a copy of the summons, First Amended
24 Complaint, and other necessary documents, along with an acknowledgment of receipt of service
25 form and self-addressed and stamped envelope for return to my office. As of the date of this
26 declaration, I have not received by mail the completed acknowledgment of receipt of service
27 form signed by an agent for the defendant, or otherwise been contacted by anyone representing
28

1 the defendant. Plaintiff will seek leave to serve the summons and First Amended Complaint on
2 this defendant by publication. Henghe LLC is one of the defendants believed to have produced
3 groundwater on properties owned by it for the unlawful cultivation of cannabis.

4 9. The delay in serving the above-named defendants was the result of lack of accurate or
5 reliable information regarding valid addresses where service could be effectuated. At one point,
6 there were more than one hundred forty (140) defendants named in this proceeding. Although
7 Plaintiff has devoted considerable resources to the effort, locating valid service addresses for
8 and effectuating service on all of the defendants has been challenging. Plaintiff and I apologize
9 to the Court for any perceived deficiency in the effort to promptly serve all defendants named
10 in this proceeding. The number of defendants who will participate in the trial(s) in this
11 proceeding has now been reduced to six (6), i.e., Shadow Mountain Ranch, LLC, the Fasoja
12 Living Trust, S.E. Combined Services, Buddhist-Town LLC, Hengh LLC, and the Prem Reddy
13 Family Trust. Plaintiff has been able to reduce the number of defendants who will actively
14 participate in the trial(s) in this proceeding from more than 140 to only 6 because of defaults
15 entered as to certain defendants and, also, dismissals, without prejudice, of: (a) persons who no
16 longer have an ownership interest in the real properties at issue in this proceeding; (b)
17 defendants who are confirmed to no longer produce or use groundwater for the unlawful
18 cultivation of cannabis; (c) defendants who are confirmed to be producing less than 10 acre-feet
19 of groundwater annually; and (d) defendants who voluntarily elected to become stipulating
20 Parties to the Judgment entered in *City of Barstow*.

21 I declare under penalty of perjury under the laws of the State of California that the
22 foregoing is true and correct, and this declaration is executed in San Bernardino, California.

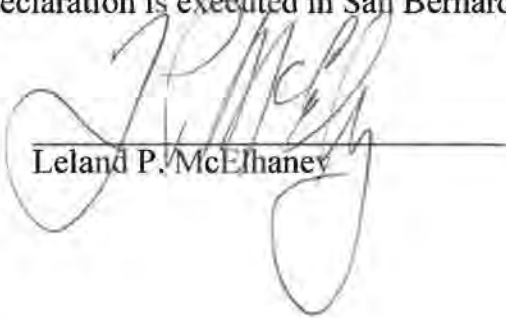

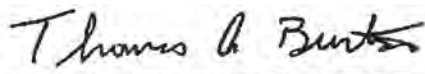
